Dear Mrs. President Bresso,

Meeting the European limit values for air quality is a big challenge for most European regions. Even though regions and cities put strong efforts in improving air quality a lot of them still struggle in fulfilling their legal obligations. This is why a group of regions from 7 EU-member states decided to join forces and to start a closer cooperation. Our informal network at the moment includes 12 Regions - representing more than 85 millions of inhabitants and more than 20% of the EU GDP of around €2,880 billions - that share specific issues related to air quality, due to a combination of strong industrial development, high population density and adverse geographical and meteorological conditions.

As part of this cooperation we are organizing a political conference on air quality in the premises of the Committee of the Regions on 10 November (morning) 2011 in order to facilitate an exchange of best practice and to discuss the needs for a further development of EU-air quality policy. We first of all would like to thank you and your team for providing the adequate location within the Committee of the Regions as well as interpretation. Your conference service is extremely helpful to us!

As we are planning the participation of our regional Ministers, State Secretaries as well as experts we very much appreciate if you as the President of the CoR could address some opening remarks to the audience. Dear colleagues form the AIR group,

First of all I would like to confirm that the "Regional Minister for Environment and Transport of Steiermark, LR Dr. Gerhard KURZMANN" has confirmed his participation on the 10th November. The signature of the MOU is a decision of the full government cabinet and this decision is under preparation right now.

Key note speech: My colleagues back home got in touch with Prof. Hausberger to check if he would be ready to widen the topic of his key note speech. Prof. Hausberger will be happy to target the topics requested by London "Euro Standards" as well as "abatement technology (including filter systems for PM as well as NOX). He will also include "tyre and brake wear". I have not received any other request for the key note speech up to now.

As Prof. Hausberger is not a health expert he does not feel competent to talk on health evidence (we would probably need a medical doctor to cover this topic) or transboundary pollution (maybe a meteorologist?). As you know from my e-mail from 28 of June he is an expert on traffic emission (see attachment). You certainly remember that the reason why we had chosen him was that he is trusted by the officials of DG Environment. As the commission trust's his research results in emissions under real term driving conditions who are much higher than the test cycle emissions (even mentioned in the CARS21 working group on emissions) we thought that he could be the right person to interest commission officials in our conference. This would also underpin our need to get more time in meeting the limit values.

In case you feel we should rather take someone else, maybe a doctor who can talk about "limit values and heath evidence" please let me know as soon as possible as we would need to cancel the booking of Prof. Hausberger.
